



What: This is a resource for teens and adult facilitators with a 60-slide PowerPoint presentation in a guided format of information and activities leading to the writing of a *CO letter* that is submitted to, and hopefully accepted by, the CO's faith or support community. The letter articulates the CO's deeply held beliefs within the three criteria for conscientious objection. The curriculum is specific, detailed, comprehensive, interactive, and adaptable. See the *Table of Contents* on back.

Why: With no draft and a Selective Service registration system linked automatically to getting a driver's license in most states, the idea of military service and conscientious objection in particular is simply "out-of-sight/out-of-mind." Yet, Selective Service registration for men turning 18 (and possibly women in the future) is still required, and it is phase I of a draft. Little thought is given either to the consequences of registration or to the formulation of a peace testimony as these teens move into adulthood. Are we running the risk of raising a generation ill-prepared to articulate and document a conscientious objection claim against all war if conscription, or phase II of a draft, is re-activated. This curriculum provides a pathway for teens, and anyone else, to do that. Past CO letters writers recognized the influence this had on their commitment to peace and non-violence.
